



Reciprocity Agreement

Aim of Agreement.

The main aim of this agreement is to enhance the development of mutual cordial relationships between the two signatory clubs, namely,

The Royal Malta Yacht Club and the

Yacht Club Italiano of ***Porticciolo Duca degli Abruzzi - 16128 Genova - Italy***

for the benefit of all their respective members and to keep all members of both clubs updated and informed of activities organised by either club.

Definitions.

Reciprocal Club,	Either or both of the two clubs entering this agreement.
Host Club,	The Club visited by the member of the Reciprocal Club.
Visiting Member,	The Member of the Club visiting the Reciprocal Club.
Member,	A bona Fide Member of the Reciprocal Club within the Rules and Bye-Laws of that Reciprocal Club.

Articles of Agreement.

It is the wish of both Clubs to enter into such an Agreement, thus allowing that, the facilities of either Club are made available for use by the Members of either Club, under the following conditions as stipulated here under.

- 1.0) Members of either Club may be permitted to benefit from the facilities and privileges of the Reciprocal Club provided that they are Members of Associate Members of their respective Club and not resident of the country of the host club.
- 2.0) Members requesting the use of facilities as per Clause 1.0 above, should do so by presenting a Letter of Introduction dated for the period of the visit and authorised by their own Club before facilities can be provided.
- 3.0) Visiting Members shall also be required to show a valid Membership Card.
- 4.0) Visiting Members are required to comply and abide by all the Rules and Bye-Laws and any authorised regulations of the Host Club.
- 5.0) All visiting Members granted the use of facilities in the Reciprocal Club shall be required to ensure that all outstanding charges and / or bills and / or accounts are settled prior to departure from the Host Club.
- 6.0) Visiting Members of either Club shall be allowed to participate in all Yachting or other Sporting events which the Host Club may be organising during the time of the visit by the Visiting Member.
- 7.0) This agreement does not provide for the enjoyment by Visiting Members of any other Reciprocal Club with which the Host Club has a similar agreement.
- 8.0) Either Host Club reserves the right to reject any Visiting Member should it result that any such member's conduct was dubious during past visits. Such occurrence will be communicated to the Visiting Member's Club were by disciplinary action may be taken by the Visiting member's Club.
- 9.0) Visiting Members who may take up residency in either of the Host Club's country should apply for membership status with the respective Host Club and should desist from making use of the benefits extended to Visiting Members after becoming residents.
- 10.0) Visiting Members shall be barred from attending or voting in any Annual or Extraordinary General Meeting of the Reciprocal Club nor participate in the election of Members to the Reciprocal Club.




